The best way to verify income is by using the IRS Data Retrieval Tool (IRS DRT) that is part of FAFSA on the Web at FAFSA.ed.gov. Paper Request Form- Use the links to download IRS Form 4506-EZ or Form 4506-T
Use the Social Security Number (or the IRS individual taxpayer identification number) and the date of birth of the first person listed on the 2021 IRS Income tax return, and the address on file with the IRS (normally this will be the address used on the 2021 IRS income tax return).
In most cases, for electronic filers, 2021 IRS income tax return information is available for the IRS DRT or the IRS Tax Return Transcript within 2-3 weeks after the 2021 IRS income tax return has been accepted by the IRS. Generally, for filers of 2021 paper IRS income tax returns, the 2021 IRS income tax information is available for the IRS DRT or the IRS Tax Return Transcript within 8-11 weeks after the 2021 paper IRS income tax return has been received by the IRS.
If the student and spouse filed separate 2021 IRS income tax return, 2021 IRS Tax Return Transcripts must be provided for both.
